Resolution 9 - Authority to Directors to issue shares pursuant to the Keong Hong Employee Share Option Scheme ("ESOS").

Pursuant to Rule 859 of the Listing Manual of the SGX-ST, shareholders who are eligible to participate in the ESOS must abstain from voting on any resolutions relating to the ESOS.

As such, Directors and employees, who are eligible to participate in the ESOS, present at the AGM have abstained from voting on Resolution 9.

The aggregate number of shares from the Directors and employees that falls under the abstention is 1,735,500 shares.

Mr Leo Zhen Wei Lionel, having been re-elected as Director of the Company, will continue to serve as a member of the Audit and Nominating Committees. He is considered to be non-independent for the purposes of Rule 704(8) of the Listing Manual of the SGX-ST.
