After this transaction, LJHB's deemed interest of 57,595,800 shares in KHHL is held through Citibank Nominees Singapore Pte. Ltd.
In addition to the above deemed interest, LJHB is deemed to have an interest in the 3,689,800 shares of KHHL owned by its indirect wholly-owned subsidiary, LJHB Capital (S) Pte. Ltd., held through iFAST Financial Pte Ltd.
